Celebrate a birthday, anniversary, wedding or graduation.

Honor someone special in your life, or someone who has done something special for you. Tribute gifts are an excellent way to recognize someone special or to mark a noteworthy event, as well as to help buy new books for Library patrons. Tribute donations are also recognized with the placement of a bookplate in a Library book, and listings in Friends publications.



Honor someone important to you with a gift to the Book Endowment Fund

Tribute gifts to The Friends of the Saint Paul Public Library are added to a Book Endowment Fund. Income from this Fund is used solely to buy books and materials at the Saint Paul Public Library, and every year, thousands of new Library books are purchased.

There are two types of honor gifts through the Book Endowment Fund:

ONE-TIME TRIBUTES

With one-time tribute gifts, for every \$25 donated, one bookplate inscribed with the name of the person being honored, and if desired, the name of the donor, is placed in a newly purchased book at the Library.

LONG-LASTING TRIBUTES

Gifts of \$500 or more endow the purchase of a book each year in perpetuity. For every \$500 donated, special wording on a bookplate – acknowledging the extraordinary effort you have made to honor a friend or relative – is placed annually in a newly purchased Library book.

Gifts to help buy Library books through the Book Endowment Fund may also be made to remember a departed loved one.
